#### Introduction

Hong Kong Science and Technology Parks Corporation (HKSTP) is now inviting qualified contractors to submit tender for Design and Build of Vibration Cancellation Tables for Micro-Electronics Centre (MEC) at No. 1 Fuk Wang Street in Yuen Long INNOPARK.

#### **Description of Works**

MEC is a purposely built building to provide manufacturing space, support facilities and specialized systems required for micro-electronics production. MEC consists of main building, central utility block and outdoor storage area. The major building works have been completed and the Occupation Permit ("OP") of MEC was obtained in October 2023. Currently, specialized system works, associated electrical works, and enhancement works are in progress, and targeted to be completed in October 2025. Meanwhile, HKSTP is inviting contractors to submit tenders for supply and installation of vibration cancellation tables in fabrication area to support the operation of MEC. The works under this contract shall include but not limited to:-

- Design, selection, supply and installation of vibration cancellation tables, including vibration isolation base, high-performance air springs, all necessary components and accessories, to meet the performance requirements;
- Modification of the existing raised floor system, finishes and fittings to suit the installation works; and
- Installation works to be carried out in class 1,000 or class 100 cleanroom and associated protection and mitigation measures.

The subject works will be carried out concurrently with the specialized system works, electrical works, and enhancement works of MEC and targeted to be completed in October 2025.
